Abraham Highschool; the State of Vermont; the Event committee and persons associated with the Event; sponsors; all Event officials and all medical volunteers and other personnel assisting with the Event, and their agents and representatives, from any and all claims, liabilities, rights or causes of action of whatsoever kind or nature, including but not limited to those arising from negligence on the part of any of the aforementioned persons or entities, for damages for any and all injuries to me or my property, or for damage caused by me or by anyone else (including Acts of God), in connection with participating in the Event.

I acknowledge that riding a bicycle is a potentially hazardous activity. I also understand that participating in the Event is a rigorous physical challenge and can result in heart attacks and any other fatal conditions. I certify I am medically able and properly trained for this Event. I agree to abide by any decision of an Event official relative to my ability to safely complete the Event. I assume all health risks associated with competing in this Event. I also know that issues may arise including but not limited to falls, contact with other participants, the effects of the weather, including high heat and/or humidity, snow, rain, extreme cold, traffic and the conditions of the road, all such risks being known and appreciated by me. I understand that this is not a closed course and I have a chance of being hit by a motor vehicle.

I give the Event the irrevocable right to use my name, picture, image, video, or photograph in any forms and in all manners, for marketing, trade, promotions, or any other lawful purposes, and I waive any right to compensation or to inspect or approve the finished product, that may be created in connection therewith.

## NACS Waiver & Release of Liability, Assumption of Risk & Indemnity Agreement, & General Media Consent & Release

IN CONSIDERATION of North American Cycle Sport ("NACS") and the event organizer allowing me to participate in this NACS-sanctioned event ("Event"); for myself, and on behalf of my spouse, children, parents, guardians, heirs and next of kin, and any legal and personal representatives, successors and assigns (collectively "Successors"), I **MAKE THE FOLLOWING CONTRACTUAL REPRESENTATIONS AND AGREEMENTS PURSUANT TO THIS WAIVER & RELEASE OF LIABILITY, ASSUMPTION OF RISK & INDEMNITY AGREEMENT, AND GENERAL MEDIA CONSENT & RELEASE ("Agreement"). I HEREBY WAIVE, RELEASE, DISCHARGE, HOLD HARMLESS, AND PROMISE TO INDEMNIFY FROM AND NOT TO SUE THE RELEASEES (defined below) FOR ANY AND ALL RIGHTS AND CLAIMS AND DAMAGES, INCLUDING CLAIMS AND DAMAGES ARISING FROM THE RELEASEES' OWN NEGLIGENCE TO THE MAXIMUM EXTENT PERMITTED BY LAW**, which I or my Successors may have or which may accrue, and related directly or indirectly with my Participation in or association with this Event. Should I or my Successors assert a claim contrary to what I have agreed to in this Agreement, we shall be liable for the expenses (including court costs and legal fees) incurred by Releasees in defending the claims.

**Releasees defined:** NACS, event owners and organizers, race directors and promoters, and their respective agents, insurers, employees, volunteers, officials, sponsors, advertisers, local associations, and affiliates; other Event Participants, government and public entities, public safety and law enforcement agencies, cities, local organizers, venues and property owners connected to or upon which the Event takes place, and each of their respective affiliated companies, officers, directors, partners, shareholders, members, agents, officials, employees and volunteers (individually and collectively, "Releasees").

### ACKNOWLEDGMENTS & REPRESENTATIONS

- Risks & Dangers: I UNDERSTAND AND AGREE THAT CYCLING IS AN INHERENTLY DANGEROUS SPORT THAT INVOLVES RISK OF PHYSICAL INJURY AND/OR DEATH. I REALIZE THE RISKS AND DANGERS OF PARTICIPATING IN CYCLING EVENTS**, whether as a rider, official, coach, mechanic, volunteer, spectator, driver, course marshal, or otherwise, (individually and collectively "Participant", "Participate" or "Participation") and **FULLY ASSUME THE RISK OF ANY INJURY TO PERON OR PROPERTY RESULTING FROM ANY OF THE INHERENT DANGERS OF CYCLING**. Inherent dangers include, but are not limited to: Collision with other Participants, pedestrians, vehicles, or other natural or man-made, fixed or moving objects; **THE RELEASEES' OWN NEGLIGENCE**, Participants of varying skill levels; surface hazards, including pot holes, roots, and otherwise imperfect course conditions; adverse weather conditions; equipment failure, loss, or damage; situations which may be beyond the immediate control of the Event organizers and other Releasees; and other undefined dangers which may or may not be readily foreseeable or are presently unknown (individually and collectively "Risks"). I understand these Risks may be caused in whole or in part by the actions, inactions, or negligence of myself, other Participants, or Releasees, my own actions or inactions, the actions or inactions of other Participants, or the acts, inaction or negligence of the Releasees, and I hereby expressly assume all such Risks and responsibility for any damages, liabilities, losses or expenses which I incur as a result of my Participation in the Event.
- Course, Rules & Regulations, Safety, Equipment, & Conduct:** I agree it is my responsibility to be familiar with the Event course(s) and agenda(s), the Releasees' rules and laws, any special regulations for the Event, and agree to comply with all such rules, laws and regulations. I understand that situations may arise during the Event which may be beyond the control of the Releasees, and agree I must always Participate so as to not endanger myself and others. I assume all responsibility and liability for the safe operation of the equipment I use and its condition, adequacy, and any modifications to that equipment. **I will always wear a helmet when riding a bicycle at this Event in order to help protect against serious head injury.**
- Anti-Doping:** I understand and agree that either the U.S. Anti-Doping Agency (USADA) Protocol or the Canadian Anti-Doping Program (CADP) may apply to this Event and it is my responsibility to comply with those rules, including submitting to drug testing. I understand that violation of anti-doping rules would make me subject to penalties including disqualification and suspension. If it is determined I may have committed a doping violation, I agree to submit to the results management authority of USADA or CADP, or to the results management authority of the UCI or my national cycling federation, if referred by USADA or CADP.
- Release of Medical Information:** I consent to the release by any third party to Releasees and their insurance carriers of my name, contact and medical information that may relate solely to any injury or death I may suffer arising from the Event.
- Media Consent & Release:** I hereby authorize NACS and Event owners, organizers, race directors and promoters, and their authorized representatives: to record my likeness and voice on electronic formats and all other media ("Recordings"); the right to use my name in connection with these Recordings; and an irrevocable right to use without limitation as to form or forum, these Recordings and my name without compensation for any purpose. I hereby release Releasees from all privacy, publicity, property rights, and all claims and demands arising from any use of Recordings which may exist now or in the future.
